Estate Planning for Alternative Assets: Sports Memorabilia

September 25, 2025 – A moderated discussion between Michael Osacky, a sports memorabilia appraiser, and Brian Dwyer, a sports memorabilia auctioneer

This discussion will aim to address some of the most pressing questions facing estate planning professionals and their clients, particularly within the realm of sports memorabilia collecting but also presenting guidance and insight applicable to other alternative assets and collectibles.

Some of the topics covered will include:

- What is important for an estate planner to ask or know about their client's collectibles?
- What is advised with respect to inventory, documentation, insurance, and storage?
- How are executors and heirs best introduced to the collection, its value, and divestment strategies?
- Why are appraisals necessary, and how are client objectives important to their utility?
- What are costs involved with documenting collections, appraising collections, and taking collections to auction?
- What legal minefields exist for collectors and their heirs?
- What are important factors to consider when choosing an appraisal or auction partner?
- What are "red flags" that might come up during the divestment process?
- Is there such thing as a typical collector or collection?
- How are unique items addressed by estate planners, appraisers, and auctioneers?

Attendees are encouraged to contribute to the program by asking questions during the course of the discussion. Moderator Brian Selvin, Esq. will lead the panelists and engage with the audience.
